Assists in creating and maintaining a recovery environment. Acts as an advocate for the needs and rights of every person.

**Position Title:** Psychiatrist /Nurse Practitioner

**Position Summary:** Directs, coordinates, and provides medical/clinical services. This includes engagement, assessment, differential diagnosis, treatment planning, medication management, family meetings, supportive psychotherapy, education, and risk assessment, and discharge planning.

**Requirements:** Physician - Doctorate of Medicine or Osteopathic Medicine with a specialty in Psychiatry, licensed by the State of Arizona, valid DEA certification and three (3) or more post-doctoral years experience in delivery of mental health treatment Practitioner - Master's degree in Nursing and completion of an accredited NP program. Must be ANCC board certified or eligible for certification as Psychiatric and Mental Health-NP. Three (3) years of psychiatric nursing experience, one year as a nurse practitioner.
